## Producer Agreement

1. The **Producer** has full power and authority to receive, **BUT MAY NOT ACCEPT, BIND OR CHANGE ANY COVERAGE WITHOUT PRIOR WRITTEN AUTHORIZATION FROM BVSA**, proposals for insurance covering such classes of risks as **BVSA** may, from time to time, authorize to be insured; to collect, receive and receipt for premiums on insurance business tendered by **Producer** to and accepted by **BVSA**, and to retain (agency billed accounts only) out of premiums so collected, as full compensation on business so placed with **BVSA**, commissions as may be agreed.
2. In consideration of **BVSA** placing insurance on the behalf of the **Producer**, the **Producer** guarantees payment to **BVSA** all premiums due whether collected or not. That is including but not limited to deposits, original premiums, additional premiums and renewal premiums in accordance with payment terms established by **BVSA**. The **Producer** further agrees to be liable to pay any return commissions at the same rate originally credited for all return premiums, adjustments and cancellations. If the **Producer** does not make timely payments as required, **BVSA** reserves the right to cancel or suspend such policies for the non-payment of premiums, and to take any other action necessary to collect.
3. **Producer** hereby represents and agrees that it is properly licensed by the appropriate authorities to transact and conduct business in accordance with this agreement and in the states so represented by the **Producer**. **Producer** hereby agrees that it has complied with all necessary laws and regulations to properly carry out the terms and provisions of this agreement, and that it will continue to abide by and comply with all necessary laws, regulations and ordinances, including local, state and federal tax laws. **Producer** further agrees that it will hold harmless, defend and indemnify **BVSA** for any noncompliance with or breach of this provision.
4. **Producer** agrees to maintain **Error and Omission's** coverage in effect during period of this agreement and will provide certificate of insurance or copies of declaration pages to **BVSA** upon request.
